

**BYLAW NO. 2-2018**

**A BYLAW OF THE RURAL MUNICIPALITY OF MOOSE MOUNTAIN NO. 63  
TO AMEND BYLAW NO. 2-2006, KNOWN AS THE ZONING BYLAW**

The Council of the Rural Municipality of Moose Mountain No. 63,  
in the Province of Saskatchewan, enacts as follows:

1. To amend Bylaw No. 2-2006 as follows:
  - A. The Zoning District Map attached to and forming part of the Zoning Bylaw is amended by rezoning land from H-Hamlet District to A-Agricultural District in the N.E.¼ Section 08-Twp. 07-Rge.03- W2M, identified as the area outlined in bold dashed lines on the attached map which forms part of the bylaw.
2. This bylaw shall come into force and take effect when it has been approved by the Minister.

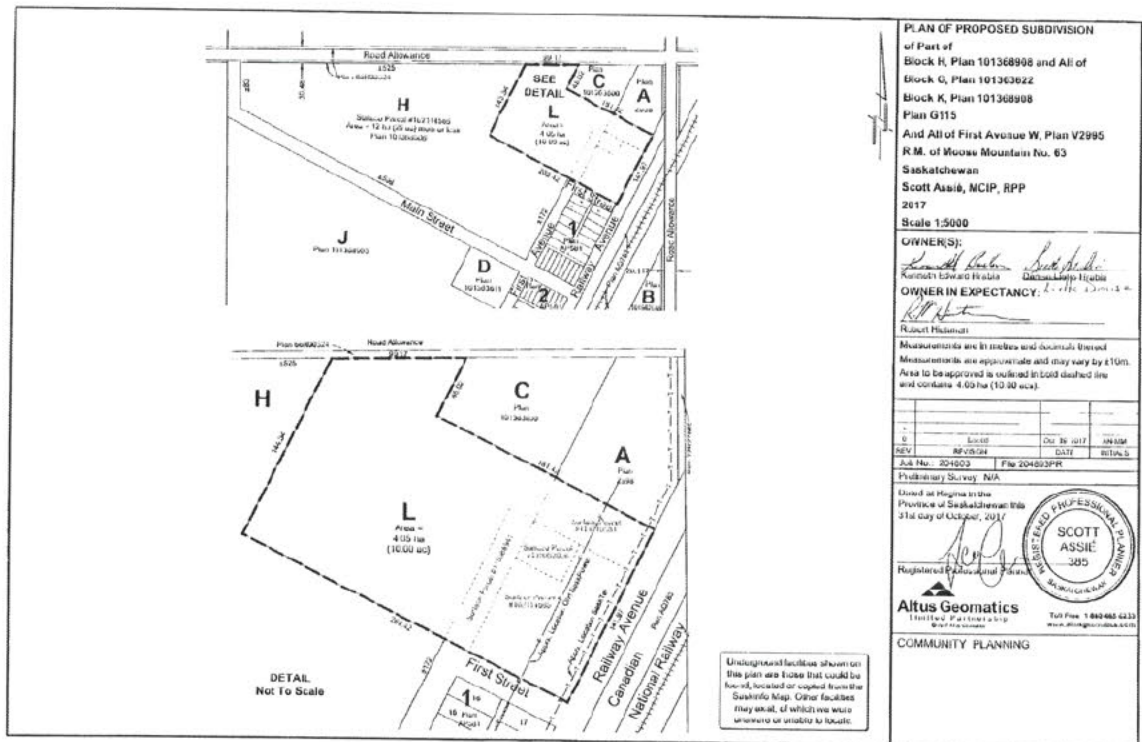
