Bylaw Number 111/59

A BYLAW OF THE RURAL MUNICIPALITY OF MOOSE MOUNTAIN, NO. 63, IN THE PROVINCE OF SASKATCHEWAN AUTHORIZING THE REEVE AND THE SECRETARY-TREASURER OF THE SAID RURAL MUNICIPALITY TO SIGN AN AGREEMENT WITH THE HOUSING COMPANY LIMITED OF CARLYLE, SASKATCHEWAN TO PROVIDE FOR THE PURCHASE OF CAPITAL STOCK IN THE SAID COMPANY:

The council of the Rural Municipality of Moose Mountain, No. 63, of Saskatchewan enacts as follows:

WHEREAS by a proposed Agreement between the Rural Municipality of Moose Mountain, No. 63, and the Mountain View Lodge Housing Company Limited of Carlyle, Saskatchewan, which Agreement is hereto annexed and made a part of this bylaw, the said Rural Municipality proposes to purchase capital stock in the said Housing Company.

AND WHEREAS the Local Government Board has approved of the said Agreement and given its consent to the passing of this bylaw;

NOW, THEREFORE, the Council of the Rural Municipality of Moose Mountain, No. 63, enacts as follows:

1. THE Agreement hereinbefore referred to between the Rural Municipality of Moose Mountain, No. 63, and the Mountain View Lodge Housing Company Limited, a true copy of which marked Schedule "A" is hereto annexed and is to be read with and form part of this bylaw, is hereby ratified and confirmed, and the Reeve and the Secretary-Treasurer of the said Rural Municipality are hereby authorized to sign and execute the said Agreement on behalf of the Rural Municipality of Moose Mountain, No. 63, and to fix the corporate seal thereto.
2. THIS bylaw shall take effect on the date of the final passing thereof.
